

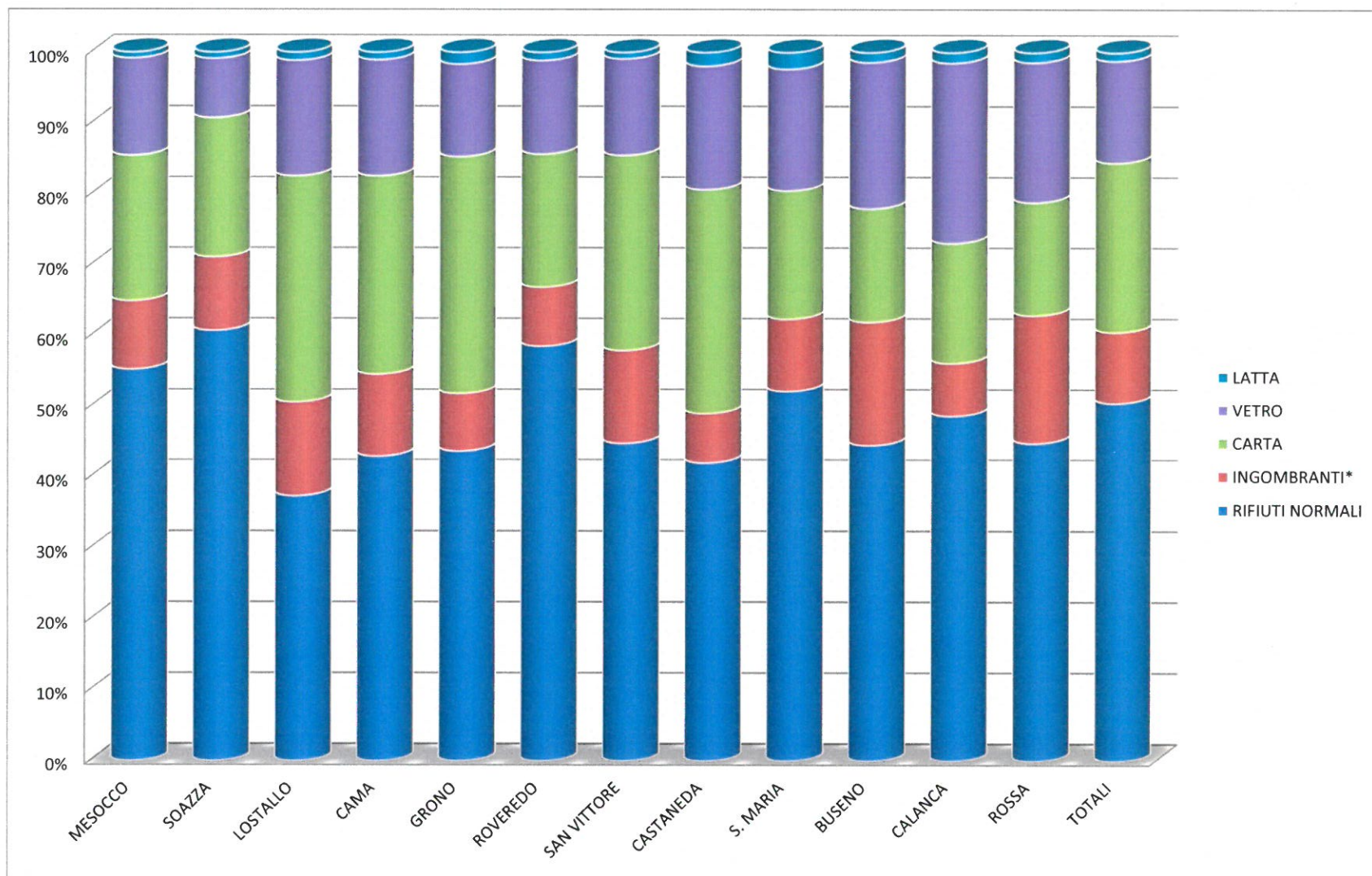

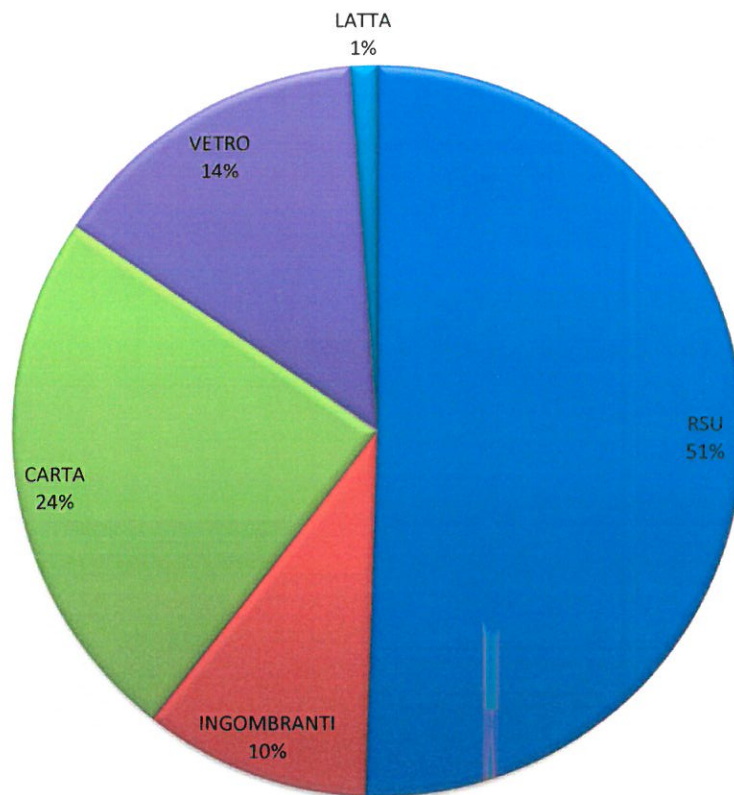
SMALTIMENTO RIFIUTI IN PERCENTUALE PER SINGOLO COMUNE
